

**PROCEEDINGS OF THE VIRTUAL REVIEW MEETING HELD
ON 02.03.2023 UNDER THE CHAIRMANSHIP OF SRI
SUBRAT SATAPATHY, IAS, I.G.R., ODISHA, CUTTACK**

The virtual review meeting was held at 11.30 a.m. on 02.03.2023 and with the 30 District Sub-Registrars of the State under the chairmanship of Sri Subrat satapathy, IAS, I.G.R., Odisha. After a detailed discussion, the following points came up.

The major points highlighted in the review meeting are as follows-

- DSRs of various districts stated that compulsory online slot booking process continues successfully in all the Sub-Registrar offices in their respective districts w.e.f. 01.03.2023.
- It is being seen that some registrant public are booking multiple online slots, may be intentionally or non-intentionally, for registration purpose as a result of which some other registrant public get suffered for non-availability of slots for their registration needs.
- Some District Sub-Registrars suggested for creating an option on IGR Portal so that a particular person/registrant public can book a particular number of slot – i.e. one or two – not more than that which may result in misuse of the slot booking process for which other registrant public in need of slot may ne debarred.
- It was also suggested that there should be an option for online booking against the slots cancelled in a particular day. In case a registrant public had booked for a slot but could not appear in the concerned SRO on the appointed date and time sue to some reasons or

the other or has changed his/her mind to present the document at some other date/time.

- DSR, Khurda, Sambalpur, Gajapati suggested to lessen the number of slots booked per hour to minimise tremendous pressure generated for proper verification of documents presented by the registrant public during presentation and registration of their document in the appointed date and time.
- IGR, Odisha raised his concern with regards the Ex-Officio SROs pertaining to slot booking made by the citizens since in many Ex-Officio SROs , registration services are being delivered on specific days and not on all the working days. As per the statutory mandate, the Technology has been so enabled that citizens can book slot on all the working days in all 191 Registration offices, availability of Registering officers in Ex-Officio offices needs to be ascertained by the authorities.
- DSR, Bhadrak and DSR, Kendrapara raised issues relating to resentment by Deed Writers on compulsory slot booking. IGR, Odisha directed them to resolve the issue through dialogue and discussion.
- IGR, Odisha directed the DSRS to ensure installation of IEC hoarding in their district by 10th March who have failed to adhere to the timeline of 15.02.2023.
- All the online services particularly E.C. and C.C.s should be issued on the same day or on the next day.
- DSRs to conduct meeting of the S.R.s of their district fortnightly and discuss issues relating to registration and other issues pertaining to administration and management of offices/public.

- IGR, Odisha advised all the DSR to submit requirement proposal in respect of their offices or sub-ordinate offices to this office who have not received funds towards purchase of furniture and fixture for their office. And those offices who have already received funds for purchase of furniture and fixture, were instructed to submit Utilization Certificate to this office at an early date for submission of the same to Government in Revenue & Disaster Management Department, Odisha, Bhubaneswar.
- IGR, Odisha instructed the DSRs of the state to submit Audit Compliance on AG Paras directly to O/o AG, Odisha in time under intimation to this office.
- IGR, Odisha directed all the DSRs to take stock of the Under Valuation cases pending in various courts where certificate cases have been instituted to follow it up till Government dues are collected. In order to collect the Govt. Revenue pending since years, tireless efforts need to be taken by all the DSRs.

The Meeting ended with vote of thanks to the chair and all participants.
