





NOTIFICATION

The 23rd May 2023

No. 2250—IX-88/2023—In pursuance of Section 69 of the Registration Act, 1908 (16 of 1908), the Inspector General of Registration, Odisha with the prior approval of the State Government as required under sub-section (2) of Section 69 thereof, do hereby make the following Rules further to amend the Odisha Registration Rules, 1988, namely :—

1. Short title and commencement—(1) These Rules may be called the Odisha Registration (Amendment) Rules, 2023.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Registration Rules, 1988 (hereinafter referred to as "the said Rules") in Rule 2, after Clause (ee), the following Clause shall be inserted, namely :—

(ef) "Online Booking of Slot" means Online time slot booking for taking prior appointment for Presentation of Document for Registration through an electronic process as may be, notified by the Inspector General of Registration, Odisha from time to time.

3. In the said rules, in Rule 25, after Clause (xiii), the following Clauses shall be inserted, namely :—

(xiv) that, prior appointment for Presentation of deed by Citizen, has been taken through "Online Booking of Slot" through an electronic process approved by and in the manner duly notified by the Inspector General of Registration, Odisha from time to time, and

(xv) that, if no prior appointment through the Online Booking of Slot as above has been taken, and the citizen has applied in writing with justification for not being able to do so, to the Registering Officer, for acceptance of the Document for Registration on demand, then on acceptance of the reasons by the Registering Officer and subject to availability of any time slot on that day be termed as "Tatkal".
