No. Regn. 2/13 - (Registration Br.) 4021 /R&D.M. In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Ministerial Service (Method of Recruitment and Conditions of Service of Clerks in the District Registration Offices) Rules, 1975, namely :-

1. (1) These rules may be called the Odisha Ministerial Service (Method of Recruitment and Conditions of Service of Clerks in District Registration Offices) Amendment Rules, 2013.

(2) They shall come into force on the date of their publication in the Odisha Gazette.
2. In the Odisha Ministerial Service (Method of Recruitment and Condition of Service of Clerks in District Registration Offices) Rules, 1975 (hereinafter referred to as the said rules) for sub-rule (1), of rule-4 the following sub-rule shall be substituted, namely:-

“(1) Recruitment to the posts of Junior Clerks in the District offices and the subordinate offices thereunder shall be made by the following methods, namely:

- (a) by direct recruitment to the extent of 90 percent of the vacancies arising in a year in accordance with rule 6, and
 - (b) by promotion from among the Group-D employees to the extent of 10 per cent of the vacancies arising in a year in accordance with rule 5”.

3. In the said rules, for rule 5 the following rules shall be substituted, namely:- 5 promotion from amongst Group-D employees shall be made in accordance with rule 11A, 11B, 11C and 11D of the Odisha Ministerial Services (Method of Recruitment to the posts of Junior Clerk in the District Offices) Rules, 1985.

4. In the said rules, after rule 18, the following rule shall be inserted, namely:-

“ 18A. Relaxation – where the Government is satisfied that it is necessary or expedient so to do in exigency of public service, it may by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons or posts in the service.”
